REPORT OF SCRUTINIZER

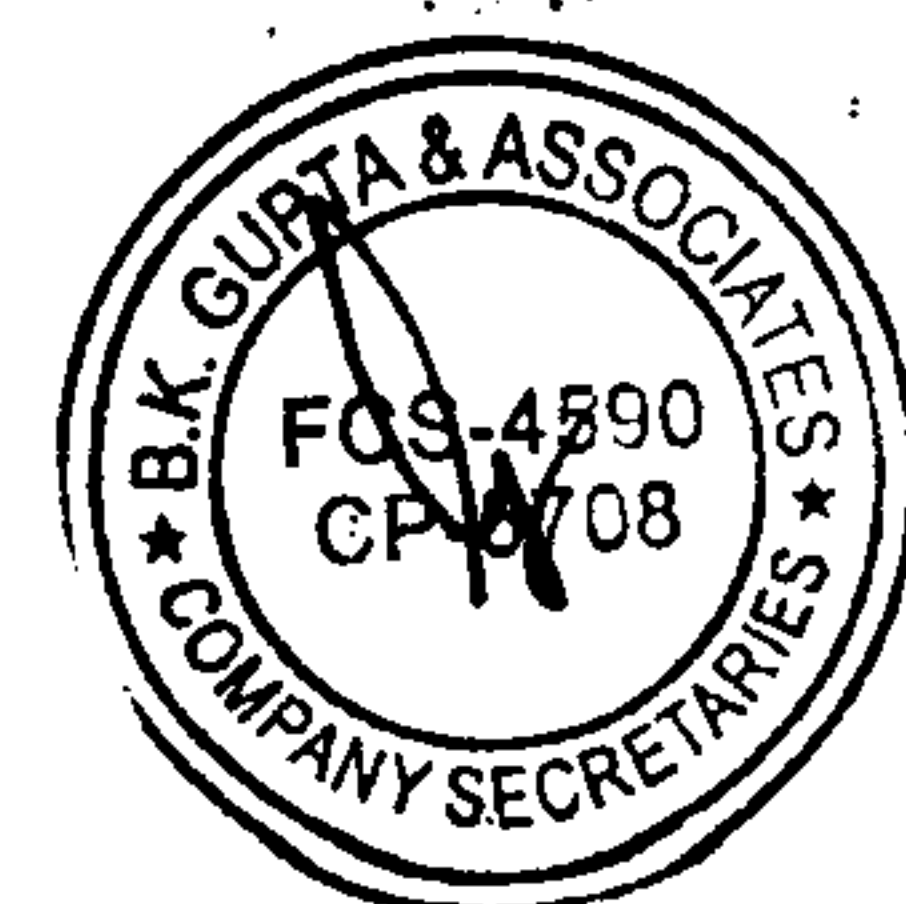

I, Bhupesh Gupta, Partner B K Gupta & Associates, Practicing Company Secretaries at 49/65, Harpal Nagar, Near Gulmor Hotel, Ferozepur Road, Ludhiana, appointed as Scrutinizer by the Board of Directors of Company for the purpose of poll taken on the below mentioned resolutions, at the 4th Annual General Meeting of Equity Shareholders of Vardhman Special Steels Limited held on 24th September, 2014 at 3.30 p.m. at Registered Office of the Company at Vardhman Premises, Chandigarh Road, Ludhiana, submit my report as under:

1. After declaration of the poll by the Chairman, ballot boxes kept for polling were marked by identification mark placed on them.
2. The ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company/ Registrar and Transfer Agents (R&TA) of the Company and the authorizations/ proxies lodged with the company. The voters were also scrutinized for the purpose of eliminating duplicate voting i.e. on e-voting as well as on poll.
