- Exceptional Items comprises re-instatement gain/loss on External Commercial borrowings (ECB).
- The Company is eligible for incentives under the Mega Project Policy of the Punjab State Government for its expansion completed during last year. Though the plant has been commissioned but the benefits have not been considered in the above results as the same is pending for sanction by appropriate authority.
- Figures for previous periods have been recast/regrouped, wherever necessary to make them comparable. The figures for the quarter ended 31st March, 2015 are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto 31st December, 2014.
- The Board of Directors has approved the above results in its meeting held on 1st August, 2015 which have been reviewed by statutory auditors as per clause 41 of Listing Agreement.
